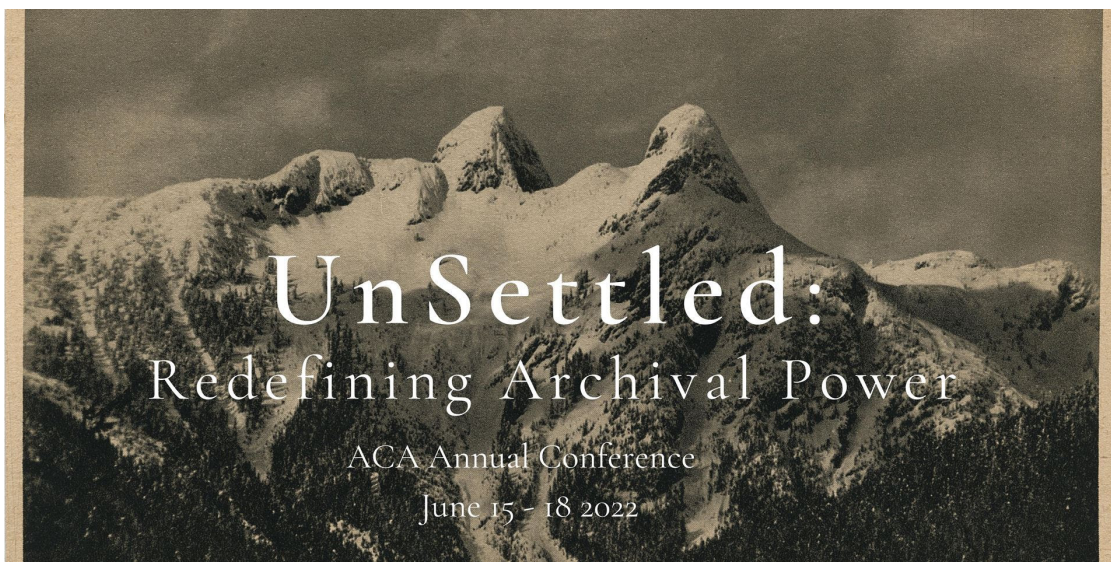

ACA 2022 – UnSettled: Redefining Archival Power

June 15-18, 2022 at the University of British Columbia, Vancouver

This year's conference will be hybrid (both in-person and online), subject to public health guidelines.

Archives are changing and transforming! Archives are repositories that help shape public and community memory. Traditional archival theory has upheld control of the historical record by colonial institutions, western perspectives, and whiteness. This power has been used to marginalize, other, undervalue, and erase diversity within the archive and public memory. As a result, colonial institutions have perpetuated their own biases against non-western worldviews to mobilize public memory in support of ongoing colonization.

Today, archives are used to empower, fill gaps, educate, and celebrate the voices and perspectives of those traditionally barred from this work. Transformative practice allows us to rethink traditional western theory, forge a path of solidarity, and uphold our work based on collective values in regards to archival work. The power of archives and memory keeping is evolving into something new. UnSettled hopes to shine a spotlight on the many ways the profession is redefining archives and archival work.

We welcome proposals in all formats, including individual traditional papers, panel sessions, full sessions, and round-tables, or feel free to suggest something new! We encourage participation from all individuals and organizations involved in memory work, including students, new professionals, and community archivists. Our goal is to hear from a variety of perspectives.

Suggested Topics:

- Implementation of TRC Calls to Action, Reconciliation, BLM, #MeToo, Idle No More, Stop Asian Hate, etc.
- Archives actively taking a stance on anti-racist, feminist, decolonial practices, and confronting systemic injustices
- Examples of community engagement related to diverse structures of organizing archives (e.g., grassroots and community-led archives, published history initiatives, memoir writing, oral history projects, etc.)
- Archives embracing ways of knowing that are new to western archival theory (e.g., culturally appropriate memory keeping)
- Archivists who have faced institutional barriers
- Data Sovereignty
- Re-examinations of archival education and/or theory
- How archival practices are continuing, growing, adapting, or reframing to work within new paradigms

Student papers and posters: There will be an additional Call for Student Papers as well as a Call for Posters later this year, with submission deadlines early in 2022. Those papers selected for the new voices (student) session will be eligible for funding.

ACA Financial News at a Glance

In collaboration with the ACAF Board and the ACA Secretariat, the audit of ACAF 2020 financial statements is underway with our member-endorsed Accountant Firm: Ouseley Hanvey Clipsham Deep LLP Chartered Professional Accountants.

In spring 2021, the ACA re-invested a conservative portion of our GIC returns in a new, equity markets portfolio according to advice provided by our RBC Wealth Management, RBC Dominion Securities Investment Advisor, Sebastien Brown, CIM. The ACA October 2021 [investment statement](#) reports positive gains on this investment.

The Membership Committee, ACA Secretariat, and Finance Committees are reviewing and refreshing reports undertaken in recent years to review ACA member categories and fees and bring them in line with the ACA Strategic Plan 2018-2021 and ACA Equity Commitments. The ACA Board will consider these findings in an effort to present a motion on amended member fee structures for member vote in 2022.

Reopening Fund for Heritage Organizations - Museums Assistance Program: The deadline for the [Reopening Fund for Heritage Organizations](#) under the Museums Assistance Program (MAP) has now been extended until **November 29, 2021**. This funding will help heritage organizations that have felt the impact of the COVID-19 pandemic as they reopen and safely welcome back visitors. Not-for-profit organizations with a heritage collection, such as museums, archives, galleries and historic sites, may be eligible to receive funding. Indigenous organizations with a heritage collection are also encouraged to apply. Organizations can receive between \$1,000 and \$100,000 in reopening support

ARMA Conference and Call for Speakers: ARMA Canada's five western local chapters (Vancouver Island, Vancouver, Calgary, Edmonton, and Saskatchewan) will be holding a records and information management (RIM) conference from October 5-7, 2022 in Kelowna, B.C. This conference is named "[Wine-ing About Records](#)," a reiteration of the very successful Whining About Records conference held in 2010, and will consist of three themed streams: Records Management Basics 101, Records Management in Indigenous Organizations, and Special Topics. It will provide an opportunity for members and non-members from a variety of professional backgrounds and levels to expand their records and information management knowledge, meet with exhibitors, and network with their peers.
